

# Is Ireland the Only Remaining Democracy in Europe?

## Why Brussels' EU Is Already Doomed

While some European politicians are still trying to sell the new EU Treaty to the people as the foundation for a bright, democratic future for Europe, the entire construct of Brussels' EU is already doomed. No political body portrayed as "democratic" can survive the following facts:

- The EU Commission, the executive body of Brussels' EU, is also its decisive lawmaker. The Parliament has no legislative power nor control over this executive. Thus, the Brussels EU construct is not a democracy but the basis for a dictatorship steered by corporate interests.
- These corporate interests, namely the chemical, petro-chemical and pharmaceutical industries, have already been behind the first conquest of Europe. The records of the Nuremberg Tribunal document that these corporate interests financed the rise of the Nazis, the preparations for WWII and the Auschwitz death camp, with the goal to create a European market from "Lisbon to Sofia" controlled by tyranny – and patents.

### The Conscience of Mankind

With the refusal of most European governments to tell the truth about Brussels' EU, their credibility has plummeted to an all time low.
